#### 1. **Apologies for Absence**.

#### 5. **Planning Applications**.

The weekly lists were received.

#### (a) Application No. 2017/0068/FUL.

Location: Field adjacent to Maes Yr Haf, Parkmill..

Proposal: Use of part of field for temporary parking of up to 25 touring caravans from 22 -

June 2017 (inc.) and 7 - 11 September (inc.).

Applicant: Gower Blue Grass Festival.

Councillors Roy Church and Viv Jones declared an interest.

After discussion, agreed to raise no objection.

#### (b) Application No. 2016/3644/FUL

Location: Tanglewood House, Lunnon, Parkmill.

Proposal: Detached garage.

Applicant: Mr. & Mrs. H. Morgan.

After discussion, **agreed** to object for the following reasons:-

The Council feels that the applicant seems to have total disregard for the Planning Authority's regulations and believes that having built a large, substantial, house with a single-storey extension to the rear of the site formerly Byways bungalow and garage, there should be no more development at this property.

Building a garage without planning permission, in full public view to its close proximity to the highway, is inappropriate.

This Council, therefore, cannot agree to this retrospective planning application.

Furthermore, the Council would like to point out that some hedgerow has been destroyed already in front of the newly constructed wall and railings.

#### (c) Application No. 2016/3514/TEM

Location: Fairwood Corner Farm, Fairwood, Gower.

Proposal: Use of land for Caravan Rally, 40 units, from 14<sup>th</sup> September – 17<sup>th</sup> September inc.

Applicant: Caravan Club.

Agreed to raise no objections.

#### (d) Application No. 2016/3093

Location: Webbs Field, Nr. Brookvale, Ilston, Gower.

Proposal: Retention of packing shed, compost toilet, gravelled parking and TB testing area

used in association with community supported agriculture.

Applicant: Mr. A. Flanagan.

Agreed to object for the following reasons:-

It appears that this application is for work already completed a year ago. The Council does not approve of people doing work and then applying for retrospective permission.

The Council is aware that several residents of Ilston are very disturbed by this application and have already made their own objections.

The Council is concerned that if retrospective planning permission were granted, the site owner would be encouraged to develop the site further without applying for consent first.

The Council therefore objects to this application.
