- 1. Apologies for absence Cllr I Brown, Cllr N Huffer and Cllr L James
- 2. **Election of Chairman** The Clerk called for nominations and it was proposed by Cllr S Pleydell and seconded by Cllr H James that Councillor Mr D Ponting be re-elected as chairman for the ensuing year. There being no further nominations Councillor Mr D Ponting was unanimously re-elected as Chairman.
- 3. **Election of Vice Chairman** The Clerk called for nominations and it was proposed by Cllr S Pleydell and seconded by Cllr C Bates that Councillor Mr R Church be re-elected as Vice-Chairman. There being no further nominations, Councillor Mr R Church was unanimously re-elected as Vice-Chairman.
- 4. **To approve the Minutes of the Annual General Meeting held on 25th May 2022 (herewith)** The minutes of the AGM held on 25th May 2022 were proposed as a true record by Cllr Pleydell and seconded by Cllr James. All members present and also present at the previous AGM agreed. The minutes were then signed and dated by the chair.

It was proposed by Cllr C Bates and seconded by Cllr S Pleydell that 5 a, b, c, d and e were all actioned for the ensuing year. This was agreed by all members present.

It was proposed by Cllr H James and seconded by Cllr S Pleydell that the clerk peruses the additional item noted in the revised standing orders and produce a list for the next monthly meeting and that these items will be actioned over the next couple of meetings for the ensuing year. This was agreed by all members present.

It was proposed by Cllr R Church and seconded by Cllr D Ponting that the AGM minutes be agreed at the next monthly meeting rather than at the next AGM as powers under the Local Government and Elections Act 2021 now allow for this. This was agreed by all members present.
- 8. **To declare a date and time for the Annual General Meeting 2024** It was agreed by all members present that the next AGM be set for 6.30pm on Wednesday 29th May at the Barham Centre and online.
